## **Job Overview**

To operate specialist machinery, mainly the seafront's tractors, to deliver a high quality cleansing function, whilst providing the highest level of customer service to all members of the public and support to the wider Seafront Operations Team.

## **Key Responsibilities**

- To carry out systematic raking of the beaches using the surf rakes and harrow to remove litter and debris restoring the beaches to a high quality level of cleanliness through the application of a rolling programme of works
- To carry out systematic maintenance of beach levels and sand movement using the tractors through the application of a rolling programme of works
- To carry out systematic clearing of the promenades using the tractors and brushes to remove excess sand deposits, maintaining cleanliness and access through the application of a rolling programme of works
- To drive, inspect and maintain a variety of equipment used in conjunction with keeping the beaches and promenades clean including tractors, associated equipment and other vehicles
- May be required to provide indirect supervision to a small group/team, mainly involving the provision of general routine guidance
- Assist the cleansing team with litter collection, vegetation and sand clearance as required
- To liaise with the Senior Ranger to ensure a safe service and provide relevant information with regards to the day-to-day operation
- To ensure the security of the seafront and associated facilities by securing all areas in accordance with the laid down procedures



- To provide a helpful and courteous service to all members of the public by assisting with general enquiries where possible and be aware of the high visibility of the service being delivered
- To comply with all Health and Safety policies and procedures •
- To undertake any other duties from time to time commensurate with the grade and responsibilities of the post
