My job improves the quality of life for the people of Bournemouth, Christchurch and Poole, East Devon and the wider South - West area working collaboratively with partner organisations, by providing clear and robust evidence and technical advice to support the delivery of flood and coastal erosion risk management services, helping to secure positive outcomes for communities at risk of flooding and coastal change now and in the future, whilst also seeking to enhance the wider-environmental outcomes of FCERM activities.

Job Overview

Working as part of multi-disciplinary teams, this role will provide support and leadership to the BCP Council and East Devon District Council Shared Service as well as broader South West partner organisations on strategic coastal risk management. Key activities will include supporting and leading on the planning and delivery of strategic FCERM initiatives, including shoreline management planning, to provide clear vision and strategic direction for managing the risks of flooding and coastal erosion now and in the future as the climate changes. This role requires a thorough understanding of the wider-FCERM sector in England, shoreline management plans and coastal change adaptation. Although not directly line managing, this role will be expected to manage project teams, particularly in relation to the development and implementation of strategic studies.

Key Responsibilities

- Work with the Strategy, Policy and Environment Manager to provide support and leadership on shoreline management planning, including:
 - Managing and maintaining key documents used by SMP management group to guide delivery of SMP actions.
 - Scoping, procuring and delivering activities required to deliver SMP actions defined in action plans.
 - Undertaking engagement with stakeholders and professional partners, including planning officers, to keep them informed about SMPs.
- Liaise with bodies with an interest in the flood and coastal erosion zones to provide advice and support, to ensure a strategic approach to the management of the 'at risk' areas.
- Support and lead on strategic studies, FCERM strategies and strategic outline cases to support sustainable management of coastal flood and erosion risks.
- Support and lead on FCERM research projects to improve understanding and develop innovative approaches to tackling FCERM challenges.
- Work with other members of the FCERM team and other stakeholders to develop appropriate approaches to coastal adaptation and resilience.
- Delivering high quality services, share and embed best practice principles of sustainable
