#### **Job Overview**

This role within BCP Council is for a Children's Occupational Therapist within the Schools Outreach Team. This role is primarily a consultative role, responsible for ensuring Mainstream Education providers across BCP have a consistent understanding of Sensory Processing difficulties and the impact they can have on Children with or without Special Educational Needs & Disabilities.

The aim is to support young people to develop effective sensory strategies to provide them with the best possible learning experience and outcomes, alongside enabling education providers to increase their knowledge, confidence and understanding in this complex area.

This role will include undertaking direct assessments and providing targeted interventions for Children who are experiencing challenges or barriers to their participation and engagement in learning primarily due to sensory or motor difficulties.

## **Key Responsibilities**

- You will work with School Leaders, SENCO's, Higher Level Teaching Assistant's and BCP education colleagues, taking a consultative approach to problem solving sensory difficulties within the classroom or education environment.
- Initiating, planning, and implementing group activities, working alongside School leaders, Teaching Staff & School Special Education Needs Co-ordinators (SENCO's).
- Provide specialist Occupational Therapy advice to Schools and Education staff, with an emphasis on Sensory Processing.
- Supported by the Outreach Team Children's Occupational Therapy Assistant you will lead on the creation & implementation of resources such as Sensory

Diets/Sensory Toolkits or Motor Programmes for individual Children and provide workable strategies that can be implemented within the school setting.

- Effective & appropriate delivery of specialist training sessions to Education staff relating to the management and understanding of Sensory Processing difficulties in the School setting.
- Using clinical observation skills to formulate strategies and advice to enable Children and Young people who are experiencing Sensory Processing difficulties to engage more effectively within the School setting and to support education providers to consider any environmental adjustments that may need to be implemented.
- Identify ongoing and future service development opportunities within the Schools outreach service.
- Represent and promote the role of the Schools Outreach OT service, lead on clinical decision making on a daily basis.
- Essential to this role will be the contribution to the SEND Statutory Assessment
  process to ensure accurate identification and intervention related to key elements
  of a child or young person's functioning, impacted by difficulties in sensory, motor,
  or perceptual skills. This will involve contributing to Education, Health Care Plans
  (EHCP's) and may involve the assessment and recommendation of specialist
  equipment such as postural seating within mainstream school settings.
- You may occasionally be required to contribute to tribunal requests.
- This role will require regularly monitoring and evaluating the effectiveness of the OT Outreach Service delivery and the interventions it provides using clear statistical and documented outcome measures.
- This role includes the professional clinical supervision of the Outreach Team OT Assistant.

- Experience working within Schools and Education settings with Children & Young people who have a range of SEND including Children and Young People with Autism Spectrum Condition (ASC) and Attention Deficit Hyperactivity Disorder (ADHD).
- Knowledge of OT assessments & Interventions relating to Children & Young people
- Supervisory experience
