My job improves the quality of life for the people of Bournemouth Christchurch and Poole by the checking and inspection of construction works on site to ensure proper and safe implementation of highway and transport improvement schemes associated with new development.

### Job Overview

To manage and provide advice on the Council's statutory obligations as Traffic and Highway Authority by checking and inspecting construction works on site for highway and transport improvement schemes associated with new development and ensuring their safe and effective implementation. To ensure compliance with approved design and specifications when the improvement schemes are implemented and agree appropriate traffic management measures are in place for safe function of the highway during construction works.

## **Key Responsibilities**

To manage and provide advice in fulfilling the Council's statutory obligations as Traffic and Highway Authority to ensure the safe and effective construction of highway and transport improvement schemes associated with new development. To support the New Development Team with the following responsibilities:

- To provide expertise for the New Development Team that provides technical advice for all new highway infrastructure relating to both major and minor development that receives planning consent, to ensure a safe, sustainable and efficient highway network to and from such development.
- To lead general checking and inspection activities of highways construction works undertaken by or on behalf of the Council.
- To undertake inspections of construction highways works with the aim of ensuring that all works are undertaken in accordance with the Contract or other agreed arrangements relating to any particular works.
- Maintain records of all inspections and actions taken following each site visit.

- Issue detailed instructions to contractors to cover safety matters and design details as required.
- Oversee condition surveys and inspections of highways and structures.
- To co-ordinate with the co-ordination of other staff, Service Units and external agencies.
- To lead the development and implementation of Council policies on construction matters including the efficient and effective delivery of construction works.
- To effectively manage a dedicated workload and be responsible for its delivery in accordance with cost, quality, and time requirements
- To ensure compliance with Council Standing Orders, Council Policies and other relevant contracts or agreements.
- To support the New Development Team to ensure that works carried out under such agreements are safe, fit for purpose and minimise future liabilities to the Council.
- To oversee Road Safety Audits during or post construction stages.
- To co-ordinate with other team members to analyse and identify issues and trends and identify solutions to improve effective delivery of New Development Team aims and objectives.
- To comply with all decisions, policies and standing orders of the Council and any relevant statutory requirements such as Health and Safety at Work Act and Data Protection Act.
- Undertake any other duties as required commensurate with the nature of the post.

- Relevant degree (or equivalent experience).
- Relevant professional qualification e.g., Incorporated Engineer (IEng) of the Institution of Civil Engineers, or similar professional qualification from organisations such as CIHT, CILT, or equivalent experience.

- Detailed knowledge of different forms of engineering contracts.
- An in-depth understanding of construction site procedures and protocols.

- Good knowledge of ICT including Excel, Word, Outlook and other programmes relevant to the role.
- Substantial Knowledge and understanding of the most recent legislation applicable including construction, highways, transportation, traffic or engineering and Health and Site Safety issues.
